

Mahidol University is one of the top universities in Thailand. It was founded in 1888 as the Sririraj Hospital and started granting medical degrees in 1893. It was renamed the University of Medical Sciences in 1943. It was again renamed in 1969 honour of Prince Mahidol of in Songkla, considered the father of modern medicine and public health in the kingdom. Although initially focused on and excelling in medical and health sciences, Mahidol University has since evolved and now offers top quality program in science and technology as well as social sciences and humanities.

The Institute of Human Rights and Peace Studies (IHRP) is a research, teaching, and outreach institute at Mahidol University. It was the first to offer a graduate degree in human rights in the Asia Pacific region. The IHRP came about as the result of the merger between the Center for Human Rights Studies and Social Development (est.1998) and the Research Center for Peacebuilding (est.2004).

The research, learning, and outreach activities conducted by the IHRP reflect a uniquely interdisciplinary approach to the study of human rights, peace and conflict, democratization, and social equity. Yearly, as many as forty students from about two dozen countries come to study at the IHRP's four graduate degree program. IHRP is also involved in peacebuilding outreach activities, especially in Thailand's southernmost provinces.

Living in Thailand

The IHRP is located on Mahidol University's main campus in the quiet town of Salaya, Nakhon Pathom, about forty minutes by bus from Bangkok. It is near enough to the capital that students can pop into Bangkok for a short visit every once in a while to refresh one's self after a long day (or week) of studies.

There is plenty to see and do in Thailand. If you're the traveling type, you'd know that Bangkok is one of the most visited cities in the world, hosting over 11.15 million foreign visitors in 2022.

Bangkok is also a dazzling city of cafes, clubs, markets, and food spots, malls, and shopping areas, complete with modern facilities and accommodations that can suit every traveler's (and shopper's) needs. In between classes, you can also sample the beautiful beaches in the south or try hiking in the mountains and hills of the north. Visit the ruins of Ayutthaya, once the largest city in the world, and the ancient cities of Chiang Mai and Sukhothai. Other Southeast Asian countries are also easy to reach from Thailand.

Thai food is one of the most soughtafter foods in the world. Spicy, sour, or sweet, Thai food is definitely one of the things that make living in Thailand enjoyable. In addition, because Thailand hosts a large number of foreign populations, different cuisines can also be found, including Indian, Chinese, Japanese, and Western dishes.

The cost of living in Thailand is relatively cheap compared to other countries.

The Ateneo de Manila University is one of the most prestigious universities in the Philippines. It is home to the Ateneo Law School, which hosts the two institutions which facilitate the APMA program in the Philippines, the Ateneo Human Rights Center and the Graduate Legal Studies Institute.

The Graduate Legal Studies Institute (GLSI) serves as a center for academic research and teaching in various legal fields, particularly in human rights law and international economic, corporate, and business law. It offers a Master of Laws graduate program that attracts some of the top students in the country. The Ateneo Human Rights Center (AHRC), on the other hand, promotes human rights by offering legal assistance, research and publication, law and policy reform and human advocacy, rights training and education. It works closely with the academe. grassroots organizations, and other society civil groups and was primarily responsible for the introduction of human rights courses in the Ateneo law curriculum.

Living in the Philippines

Both the GLSI and AHRC are located in the Ateneo Professional Schools building in Makati City. considered The city is the business capital of the Philippines. At the moment UGM does not have a special dormitory for foreign students. However, students are offered various choices of local dormitory ("kos" or "kos-kosan"). Most of these kos are privately owned. The monthly rent depends on the location, facilities and size of the room. Kos dormitories are also surrounded by many kinds of warung (local small restaurant for students with cheap prices e.g. S1 for a complete meal) and other student's facilities.

UGM is located in Yogyakarta (Jogja for short), once the capital of Indonesia and located in the central-southern part of the island of Java. Being historically wealthy, Jogja is also a heaven for archaeologists yearning to study ancient structures such as Borobudur, the world's largest Buddhist temple.

Living in Nepal

The most common accommodations for students in Kathmandu are hostels and homestays. Hostel rooms usually have two or three people in each room, and meals are oftentimes also provided. In homestays, students usually rent a room in a family home and they have to take care of their meals most of the time. There are also some apartments for rents for those who like more privacy, but they can be quite expensive. Kathmandu Valley is the location of several cities that served as capitals of various polities in Nepal at various times and, thus, has a lot to offer to those who like a trip down history lane. The Himalayas also form the northern border of Nepal, so those who wish to commune with nature during breaks from school will definitely find plenty to do.



WHAT'S APMA

What is **APMA**?

The Asia Pacific Master of Arts in Human Rights and Democratization, better known as APMA, is one of seven regional master's programs under the Global Campus of Human Rights.

The program is designed for those seeking greater understanding of regional and global human rights and democratization issues. The program is suitable for human rights practitioners and activists, for those engaged in related fields, or for new students who have just completed their first degree.

By the end of the program, students will have: 1) Excellent knowledge of theory and practice of the promotion and protection of human rights and democratization 2) Tested their ability to undertake independent scholarly research on current human rights and democratization issues in the Asia Pacific region 3) The capacity to put their academic understanding of human rights and democratization to use in real situations.



Program Structure

Students take up eight courses over the two semesters. These courses include:

Human Rights and Democratization Research Human Rights and Democratization Intensive Human Rights and Democratization Practicum Practical Skills in Human Rights Protection and Promotion Concepts of Human Rights and Democratization Human Rights Norms and Mechanisms

In addition, students are required to take up an Applied Research course where they get to choose whether to conduct an internship with a human rights organization or write an applied research paper in cooperation with a human rights organization.

Students take four courses during the first semester in Mahidol University, which is August to December of the academic year. In January of the second semester, students take part in the Intensive Course, a series of lectures and field work on a particular human rights issue that changes yearly. Examples of issues include Borders, Migration, and Human Rights (AY 2018-2019), Development and Human Rights (AY 2019-2020) and Critical and Emerging Human Rights Issues (AY 2022-2023). Students then proceed to their chosen partner university (Ateneo de Manila University in the Philippines, Kathmandu School of Law in Nepal, University of Colombo in Sri Lanka, or Universitas Gadjah Madah in Indonesia), where they take their remaining courses.



Student Financial Guidance

Fees and funding

Fees

Students will have to pay approximately THB 200,000 (EUR 5000, USD 5500) for the duration of the APMA program. This excludes food, accommodations, and other associated costs.

Funding

The European Commission (EU), through the European Instrument for Democracy and Human Rights, is currently offering full and partial scholarships for students from the Asia Pacific region to study in the APMA program.

Student Financial Guidance

European Union APMA Scholarship

Every year, at least 20 students are awarded scholarships under a grant by the Global Campus of Human Rights which is an EU-funded global network of universities for human rights and democracy education. In order to be eligible for the APMA Scholarship, students must be a national as well as resident of any of the countries in the Asia Pacific region.

Scholarship Criteria

Scholarships will be awarded according to a competitive combination of at least two of the following selection criteria:

- Regional representation
- Demonstrated interest in and commitment to human rights and democratization
- Strong academic background and/or research ability and/or relevant professional experience
- Inclusion and diversity of student body
- Future contribution to the field of human rights and democratization in the Asia Pacific region

Coverage

The scholarship coverage period is for twelve (12) months, starting from August/September of the academic year. If the recipient does not complete the degree within 12 months, the recipient shoulders any further costs to complete the program.

Throughout their studies, students will not only be encouraged to share their opinions in-class with their fellow classmates and lecturers, but they are also welcome to voice concerns regarding their grading or student behavior with IHRP lecturers. During the Introduction Week, lecturers will explain the various processes and mechanisms that are available to students, in order to ensure overall wellbeing of everyone during their studies at Mahidol University.

ANTI-SEXUAL HARASSMENT PROTOCOL

The IHRP seeks to strike a balance between acknowledging a student's rights of privacy and reputation and honoring the IHRP's duty to protect students and create a safe working and study environment. The IHRP has zero tolerance for any and all forms of sexual harassment. tackle said issue.

4. While we recognize that Mahidol and IHRP support facilities and services are lacking for sexual harassment issues, the THRP will endeavor to provide information on any support services available.

GRIEVANCE MECHANISM

IHRP has a commitment to human rights principles, and to applying and defending those principles in creating a safe and supportive learning and working environment.

IHRP treats everyone with respect and recognize the diversity of IHRP faculty, staff, and students. Mindful of differing cultures, religions and values around relationships, IHRP strives to create an environment free of sexual harassment and provides information on existing support services available.
